

## Luke Rees Inspires Referral Scheme T&Cs.

Please read these Terms and Conditions before you participate in the Luke Rees Inspires Referral Scheme, as these will apply. If you do not agree with these Terms and Conditions, you must not participate in the Luke Rees Inspires Referral Scheme.

- 1. The promoter of the Luke Rees Inspires Referral Scheme is Luke Rees Inspires.
- 2. These terms and conditions apply to any participant in the Luke Rees Inspires Referral Scheme, whether as a referrer or a referee.
- 3. - 6. Successful referrals can be collected and used together to increase discount. A total of 3 successful referrals can be used at once equalling the max total discount of 30%.
- 7. Referral discount can only used when booking half or full day events.

- 9. Once a Successful Referral has been made, we will email both you and the New Customer with your respective. Rewards to the email addresses designated by each of you to us in writing.
- 10. We reserve the right to substitute another reward or item of equal value to the Reward.
